# Dorchester Fair Rules & Regulations PLEASE READ CAREFULLY BEFORE SIGNING

- 1. You must report to the fair office upon arrival to register and be directed to your allotted space. Two weekend passes are provided with each paid application, additional passes are available for purchase.
- 2. Vendor fees are non-refundable and due within 10 days of acceptance.
- 3. **Vendors set up Friday October 7**<sup>th</sup> from 9am-6pm. Vendors must remain open during entire fair operating hours as specified on pg 1.
- 4. Vendor approval and space allocation is at the discretion of the Dorchester Fair Board.
- 5. Multiple vendors selling identical products are generally not allowed. However; vendors of competitive brands or types may be considered.
- 6. Sharing, subletting or other changes must be approved in writing by the Dorchester Fair Board.
- 7. The sale of knives, firearms, pornography and drug paraphernalia is strictly forbidden.
- 8. Vendor must supply their own extension cords which must meet Canadian Safety Standards and be properly secured.
- 9. Vendor must park in general parking area, no vehicles allowed on fairgrounds during fair hours.
- 10. **INSIDE VENDORS** will receive 1 6' table plus 2 chairs. **OUTSIDE VENDORS** will supply their own tent/canopy, table, chairs etc.
- 11. Inside vendors are not open to the public until Saturday. Outside vendors may open Friday afternoon/evening if desired.

#### **HOLD HARMLESS AGREEMENT**

I shall indemnify and Hold Harmless the North Dorchester Agricultural Society, their members, agents, and employees from and against all claims, demands, losses, costs, damages, suits or proceedings by any third parties that may arise out of, or may be attributed to all operations performed by or carried out by the North Dorchester Agricultural Society, their agents, employees or anyone for whose acts they may be held liable howsoever caused.
