## Dorchester Fair Rules & Regulations

### PLEASE READ CAREFULLY BEFORE SIGNING

1. You must report to the fair office upon arrival to register and be directed to your allotted space. Two weekend passes are provided with each paid application, 1 for the applicant and assistant, additional passes are available for purchase.
2. **Vendors set up Friday October 6<sup>th</sup>** from 9am-6pm. Vendors must remain open during entire fair operating hours as specified on pg. 1.
3. Vendor approval and space allocation is at the discretion of the Dorchester Fair Board.
4. Multiple vendors selling identical products are generally not allowed. However, vendors of competitive brands or types may be considered.
5. Sharing, subletting or other changes must be approved in writing by the Dorchester Fair Board.
6. The sale of knives, firearms, pornography, and drug paraphernalia is strictly forbidden.
7. Vendor must supply their own extension cords which must meet Canadian Safety Standards and be properly secured.
8. Vendor must park in general parking area, no vehicles allowed on fairgrounds during fair hours.
9. **INSIDE VENDORS** will receive 1 6' table plus 2 chairs. **OUTSIDE VENDORS** will supply their own tent/canopy, table, chairs etc.
10. Inside vendors are not open to the public until Saturday. Outside vendors may open Friday afternoon/evening if desired.

### WHO CAN APPLY?

1. Artists and individuals/groups with handmade, original, unique, eclectic, and thoughtfully created wares for sale.
2. 90% of merchandise must be hand made except for repurposed, vintage or up-cycled products

### HOLD HARMLESS AGREEMENT
